This was a full day session with local speakers and national speakers. Key topics included Minnesota animal law, forensic photography, and how to identify, document, and report animal cruelty. Over 50 veterinarians attended. The second day we also hosted a one-hour session on identifying animal cruelty to about 200 veterinarians. For the multi-day conference, Animal Folks had a booth to distribute literature and meet with veterinarians, veterinary technicians, and vet students. * Law Enforcement Policies and Procedures - In pilot training sessions on animal cruelty, Animal Folks learned that policies and procedures were needed to clearly explain Minnesota's animal cruelty statutes, so laws would be interpreted correctly.
