Veterinarians-practice without license or permit.

On or about December, 2006, within the County of Otter Tail, one KATHY JO BAUCK, hereinafter referred to as the defendant, did practice veterinary medicine in the state without having first secured a veterinary license or temporary permit by neutering a miniature Schnauzer puppy purchased by Missy Becker Cook.

## Count 2

Veterinarians-practice without license or permit.

In Violation Of:

156.10

Penalty:

0-1 years and/or \$3,000 fine

On or about August, 2007, within the County of Otter Tail, one KATHY JO BAUCK, hereinafter referred to as the defendant, did practice veterinary medicine in the state without having first secured a veterinary license or temporary permit by administering medication on a Basset Hound owned by Misty Kain through the prescription of medicine of 50 mg. of Doxecycline to be administered twice a day, plus one-half teaspoon of children's Tylenol every four hours and the administration of a canine medication called Parvel to the same dog.

Count 3

Veterinarians-practice without license or permit.

In Violation Of: 156.10

Penalty: 0-1 years and/or \$3,000 fine

On or about August and September, 2007, within the County of Otter Tail, one KATHY JO BAUCK, hereinafter referred to as the defendant, did practice veterinary medicine in the state without having first secured a veterinary license or temporary permit by vaccinating ShitzuPeek and a Havanese Schnauzer dogs owned by Karla Sazama.

#### Count 4

Veterinarians-practice without license or permit.

In Violation Of: 156,10

Penalty:

0-1 years and/or \$3,000 fine

On or about September 13, 2007, within the County of Otter Tail, one KATHY JO BAUCK, hereinafter referred to as the defendant, did practice veterinary medicine in the state without having first secured a veterinary license or temporary permit by performing a C-section on a female Yorkshire Terrier at Pick of the Litter Kennels.

## Count 5

Veterinarians-practice without license or permit.

In Violation Of: 156.10

Penalty:

0-1 years and/or \$3,000 fine

On or about December, 2006, within the County of Otter Tail, one KATHY JO BAUCK. hereinafter referred to as the defendant, did practice veterinary medicine in the state without having first secured a veterinary license or temporary permit by prescribing 100 mg. tablets of Doxycycline Hyclate to a Pub/Beagle named Stewy owned by Lisa Roberts.

#### Count 6

Cruelty to Animals

In Violation Of: 343.21 Subd. 7 and 9

Penalty: 0-90 days and/or \$1,000 fine

On or between August and September, 2007, within the County of Otter Tail, one Kathy Jo Bauck, the defendant, did willfully instigate or in any way further any act of cruelty to any animals, or any act tending to produce cruelty to animals, by picking up a puppy that had been born with a hole in its intestine and whacking its head against a pole in the barn of her facility at Pick of the Litter Kennels and throw the puppy in the garbage.
