She had a yellow discharge from her eyes and nose and 3 days later ended up in the hospital with a high fever, dehydration, bloody diarhea and a wheezy cough. Throughout her life she has had obsessive drinking when stressed problems, fear anxiety, fear aggression, OCD grooming her 4 feet till they were bald and full of sores. Then a year ago so was diagnosed with small intestinal bacterial overgrowth and she has had intermittent urinary tract problems including calcium oxylate crystals.

Then suddenly last November she had 5 severe seizure's in one day at 6 years old which makes her to old to suddenly develope severe epilepsy and my Vet is concerned that somewhere along the long of people that she transferred to she was either exposed to or had distemper which would account for her bizarre problems all her life and the brain damage could be at the core of her sudden seizure disorder. We really need to know all inspection reports at any of the facilities she was at before I purchased her and need to know if there was any distemper problems at any of these facilities.
